## 400-HOUR TRAINING LIST

The following are the **required course categories and hours for eligibility** in the Firefighters Incentive Program, as approved by the Commission on Fire Protection, Personnel, Standards, and Education. It is recommended that a paid firefighter have these **required 332 hours** prior to the individual actively engaged in emergency situations.

Remaining 68 hours are elective and may be subjects listed on KFS-1 excluding EMT and First Aid, which are limited to 68 hours.

\*Any person who had zero (0) career training hours as of July 1, 2000, must also complete the eight (8) hour "Survival course. These eight (8) hours shall be recorded in Category B. These eight (8) hours are in addition to the currently required ten (10) hours for a total of eighteen (18) hours in Category B.

\*\*Any person who had zero (0) career training hours as of July 1, 2001, must also complete the sixteen (16) hours "Firefighter Survival and Rescue" course. These sixteen (16) hours shall be recorded in Category B, and are in addition to the currently required ten (10) hours for a total of twenty-six (26) hours in Category B. Additionally, any person with zero (0) training hours as of July 1, 2001 must also complete a four (4) hour "Wildland Firefighting Awareness Level" course. These four (4) hours shall be recorded in Category M. These four (4) hours are in addition to the currently required twenty (20) hours for a total of twenty-four (24) hours in Category M.

It shall be each department's responsibility to maintain proper documentation that these courses have been completed. This documentation may be subject to audit by the Fire Commission.
